Companies and individuals who are operators of several plants up to a total output of three megawatts pay the same amount of membership fee as a member who operates a plant of corresponding size. If the total installed capacity exceeds three megawatts, the contribution is paid for a three-megawatt plant and then a contribution of €250 for each additional plant, regardless of the size of the plant.

*) The installed capacity in the sense of this fee system does not include the additional capacity installed as a result of flexibilization.

**) Managers in the sense of the fee system are persons who cultivate substrates on behalf of the owner of biogas plants, spread digestates or take over supervision and control work. The German Biogas Association can request suitable proofs to ensure that managers are not owners of the biogas plant and do not participate directly in the business success of the plant.

The annual fee is calculated on the basis of the fees in the table above. If membership begins during a calendar year, the membership fee is prorated (quarter based). The assignment to the fee class can be seen in the table above. Members are required to confirm every year that they pay the correct rate. The annual fee is payable in one amount either at the beginning of a calendar year or on the date of entry as member. Payment of the fee should be made within 14 days of receipt of the invoice. Members delaying payment of the membership fee for more than 12 months despite a reminder will be excluded from membership.

Important note: Please note that the German Biogas Association is a Chamber 1 member of the Bundesverband Erneuerbare Energien e.V. (BEE). Members of the GBA are therefore indirect members of the BEE and can utilise the corresponding services. If there is a regional Chamber 1 Renewable Energy Association (LEE) in the member's federal state, the FvB member must also become a member of this LEE.
